NOMINATION PROCESS

Canadian Association of Rocketry is holding elections for **President, Vice President,** and **Secretary/Treasurer**. These positions are nominated together as a slate for election. Term of service will be 2 years.

Nominees must meet the following conditions:

- A) Have a current CAR/ACF membership in good standing.
- B) Be headquartered in the region for which you would represent if elected.
- C) Have an identified positive and supportive interest in CAR/ACF's activities
- D) Be willing to serve on one or more of its Committees, Task Forces, or Projects during the term of the position at the request of the Board of Directors.

Nomination and candidacy application must proceed as follows:

- Candidates for the Officer positions may **not** nominate themselves.
- Consent by the Candidate must be given in advance ahead of submitting any nomination forms.
- An official nomination form must be completed, signed, and submitted by a current CAR/ACF member by the specified deadline below.
- Submit a brief candidate's statement/biography of less than 500 words for each of the three positions.
- Optional but recommended: a headshot photo by the specified deadline below.
- All forms must complete, signed, scanned, and emailed in their entirety to the address listed below, **before 12:00 (Noon) Mountain Standard Time on January 30th, 2023**. Time of receipt will be recorded.
- Failure to comply with the above rules will make the nomination invalid.
